Questions C.54 and C.54.a ask about formal agreements with child care partners during the program year.</li> </ul>

This addition does not change the original intent of the question but clarifies it, in light of the new Early Head Start Expansion/Child Care Partnership grant awards.</li> </ul> </li> </ul>
